KIIM-FM'S "COUNTRY THUNDER GRAND REMOTE GIVEAWAY" CONTEST OFFICIAL RULES

The Station will conduct the **KIIM-FM'S "COUNTRY THUNDER REMOTE GIVEAWAY"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. 5. Winner Selection. On or about 12:00PM MST March 30, 2019 Station will select one (1) entry for the Grand Prize in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant <u>MUST BE PRESENT TO WIN</u>. (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the

Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.
