KIIM-FM'S "TACOS FOR A YEAR" CONTEST OFFICIAL RULES

The Station will conduct the **KIIM-FM'S "Tacos for a Year"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the 180 days. Void where prohibited by law. The term "immediate family members" includes spouses, parents and stepparents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - 2. Contest Period. The Contest entry period will begin at 8:20am MDT on April 8, 2024 and will run through 11:59pm MDT on May 3, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** There are two (2) ways to enter this Contest.

Weekday Text To Win: Listen to the Station weekdays at 8:20am, 12:20pm and 4:20pm MDT hours during the Contest Period for Station to give a keyword. When the Station plays the "cue-to-text" sounder, listeners should text the designated keyword spelled correctly to the Station at 520-369-5446 to enter to win.

Taco Tuesday Text to Win: Listen to the Station Tuesdays at 6:20am, 7:20am, 8:20am, 9:20am, 10:20am, 11:20am, 12:20pm, 1:20pm, 2:20pm, 3:20pm, 4:20pm, 5:20pm and 6:20pm MDT during the Contest Period for Station to give a keyword. When the Station plays the "cue-to-text" sounder, listeners should text the designated keyword spelled correctly to the Station at 520-369-5446 to enter to win.

<u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to text later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

All entries must be received by 11:59pm MDT on Friday, May 3, 2024, to be eligible for the Grand Prize drawing.

Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry per keyword by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.

- 4. **Winner Selection.** On or about 10:00am MDT on Monday, May 6, 2024, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within one (1) day of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. The Grand Prize winner will receive \$1,000 Cash Card

The approximate retail value ("ARV") of the prize is One Thousand Dollars (\$1,000).
