KIIM-FM, K-HIT AND THE VIBE'S "NATIONAL MARGARITA DAY" CONTEST OFFICIAL RULES

The Station will conduct the **KiiM-FM**, **K-HIT and The Vibe's "National Margarita Day"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age twenty-one (21) years older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the 180 days. Void where prohibited by law. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. - 2. Contest Period. The Contest entry period will begin at 6:00am MT on Thursday, February 22, 2024 and will run through 7:00pm MT on Thursday, February 22, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

On-Air & Text:

KIIM-FM & KHYT-FM: Listen to the Station on Thursday, February 22, 2024 between 6:00am and 7:00pm MT during the Contest Period for Station to give a keyword. Keywords will be announce once per hour. When the Station announces the keyword, listeners should text the designated keyword spelled correctly to the Station at 520-369-5446 (KIIM-FM) or to 520-848-1075 (KHYT-FM) to enter to win.

KSZR-FM: Listen to the Station on Thursday, February 22, 2024 between 6:00am and 6:00pm MT during the Contest Period for Station to give a keyword. Keywords will be announce once per hour. When the Station announces the keyword, listeners should text the designated keyword spelled correctly to the Station at 520-696-3017 to enter to win.

<u>*Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:*</u> Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to text later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

All entries must be received by 11:59pm MT on Thursday, February 22, 2024 to be eligible for the Grand Prize drawing.

Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per day. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry per keyword by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.

- 4. **Winner Selection.** On or about 10:00am MT on Monday, February 26, 2024 Station will select one (1) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- 5. Verification of Potential Winner.
