KIIM-FM'S "ROAD TRIP TO LAINEY WILSON" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KIIM-FM ("Station"), 575 W Roger Road Tucson, AZ 85705, during available business hours Monday through Friday, on the Station website www.kiimfm.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **KiiM-FM's "Road Trip to Lainey Wilson"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age twenty-one (21) years older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the 180 days. - 2. Contest Period. The Contest entry period will begin at 5:00am MDT on Thursday, April 4th, 2024 and will run through 11:59pm MDT on Thursday, April 25, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

<u>Van Stop</u>: Attend a van stop at Corbett's (340 N. 6th Avenue Tucson, AZ 85705) conducted by Station on Thursdays, April 4 – 25, 2024, between 8:00pm and 10:00pm MDT and complete an entry form. **Limit one (1) entry per person per day.** All entries must be received by the deadline stated at the remote broadcast.

<u>Text</u>: Listen to the Station Thursdays during the contest period between 6:00am and 10:00am, 10:00am - 3:00pm and 3:00pm - 7:00pm MDT during the Contest Period for Station to give a keyword. When the Station plays the "cue-to-text" sounder, listeners should text the designated keyword spelled correctly to the Station at 520-369-5446 to enter to win. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number per keyword.

4. **Winner Selection.** On or about 10:00am MDT on Friday, April 26, 2024 Station will select one (1) potential winner(s) in a random drawing from among all valid entries received by Station during the

Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
