KIIM-FM'S "DISNEYLAND® RESORT SONG OF THE DAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KIIM-FM ("Station"), 575 W Roger Road Tucson, AZ 85705, during available business hours Monday through Friday, on the Station website www.kiimfm.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **KiiM-FM's "Disneyland® Resort Song of The Day"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the 180 days. Void where prohibited by law. Employees of Station, Cumulus Radio LLC and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and stepparents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- Contest Period. The Contest entry period will begin at 6:00am MT on Monday, August 4, 2025, 2025 and will run through 7:00pm MT on August 22, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

On-Air: During the Contest Period, listen to the Station weekdays at or around 6:40am, 7:40am and 8:40am MT for the "Disneyland Resort Song of the Day" announcement. The Station will announce what the song is for that day and the one (1)-hour window during which it will play later that day (before 6:00pm MT). Immediately following when the Station plays the "Disneyland Resort Song of the Day," listeners should call the Station at (520) 369-5446. Caller nine (9) to the Station, as determined by the Station in its sole discretion, will be eligible to win a Prize or the Grand Prize (each a "Qualifier"). There will be fifteen (15) Qualifiers in this Contest. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. **Winner Selection.** On or about 7:00am on Monday, August 25, 2025, Station will select one (1) entry for the Grand Prize in a random drawing from among all valid Qualifiers. The Qualifiers that do not win the Grand Prize will win a Prize. The Qualifiers will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of

eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days will result in disqualification. The Qualifiers that are awarded a prize are each a "Winner."

- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within one (1) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.  - Four (4) 2-Day, 1-Park per day Disneyland® Resort tickets

The approximate retail value ("ARV") of each Prize is One Thousand Three Hundred Twenty Dollars (\$1,320).

Grand Prize. One (1) Grand Prize will be awarded in this Contest. The Grand Prize Winner will receive:

- Hotel accommodations for four (4) people (one (1) standard studio/quad occupancy, including room tax, subject to certain room availability) for up to two (2) consecutive nights at a Premises (as defined below) hotel or Premises-area hotel selected by Prize Provider in its sole discretion. Standard daily hotel parking at the Premises is not included unless Winner resides within two hundred fifty (250) miles of the Premises.
- Four (4) 3-Day, 1-Park per Day Disneyland® Resort tickets

The ARV of the Grand Prize is Three Thousand Two Hundred Twelve Dollars (\$3,212).

If any prize or a portion of any prize is postponed, cancelled, or otherwise unavailable due to disease, epidemic, pandemic, quarantine, any acts of government and/or any reason that is beyond the control of Station or any Sponsor, then no substitution shall be provided. Station and any Sponsors make no representation or warranty about the safety of any prize. Prizes must be used by September 15, 2026 (subject to blackout dates).

Grand Prize fulfillment is subject to certain hotel/room availability at the Disneyland Resort ("Premises"). Hotel must be booked through a travel agent as designated by Prize Provider at least forty-five (45) days prior to arrival. Block-out dates apply. Theme park tickets are subject to the terms and conditions set forth herein and included on the theme park tickets.

Both a theme park ticket and separate theme park reservation for the same park on the same date are required for park entry for the Winner and each eligible guest (each a "Guest"). Theme park reservations and tickets will be required for each day of the visit and must be obtained before visiting. Park reservations are limited and subject to availability. Park reservations do not guarantee park admission or access to any experience, attraction, or offering. - 7. Entry Conditions and Release. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 11. **Limitations of Liability.** The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize.
